#### Course Description

Field and laboratory problems for advanced students. Fifty clock hours of laboratory and field work for each semester hour credit, for up to three semester hours any given semester. For a maximum total of six semester hours of independent research, this course can be repeated.

Graduate students can gain experience conducting field and lab work, analyzing data, and processing samples. This represents an opportunity for students to get involved with and contribute to current research. As part of this lab group, there will be lab meetings in which students will present and discuss emerging issues in wildlife ecology (participation is required).

#### Learning Outcomes

- 1. Conduct field or lab experiments to collect data with validity.
- 2. Process data.
- 3. Analyze data using appropriate statistical methodologies.
- 4. Evaluate results using supporting scientific evidence.

# **Prerequisites**

In graduate program at TCU.

#### **Instructional Methods**

All students will conduct their own field research, data analysis, and report writing at times that are suitable for their selected individual project.

A personal schedule will be laid out for the course of the semester.

# Course Policies and Requirements

The student will work with Dr. Tory Bennett or her graduate students to undertake a directed research project that meets the course description and is consistent with the research objectives of the Bennett lab.

#### Student are expected to:

- Participate in undertaking a research project.
- Participate in weekly or bi-weekly research meetings.
- Complete reading assignments (e.g. books, book chapters, and scientific articles) on time.
- Provide timely feedback on the progress of their research project. This should be done during the regularly scheduled research meetings and an excel spreadsheet detailing the date, number of hours and the task undertaken.
- Let Dr. Bennett know when assistance is needed.
- Either present their research to the department as an oral presentation or create a written account of the research. The latter may include a manuscript-style write-up or report depending on the extent of the research conducted. This expectation will be communicated with them prior to the course starting and again at the beginning of the course. Expected progress and schedule will be presented to them at this time.

#### Grading

The course grade will be derived from two components. A spreadsheet with dates, activities conducted and number of hours will be completed and submitted regularly to Dr. Bennett.

# Obligations to Report Conduct Raising Title IX or VAWA Issues

Mandatory Reporters: All TCU employees, except Confidential Resources, are considered Mandatory Reporters for purposes of their obligations to report, to the Coordinator, conduct that raises Title IX and/or VAWA (Violence Against Women Act) issues.

Mandatory Reporters are required to immediately report to the Coordinator information about conduct that raises Title IX and/or VAWA issues, including any reports, complaints or allegations of sexual harassment, discrimination and those forms of prohibited conduct that relate to nonconsensual sexual intercourse or contact, sexual exploitation, intimate partner violence, stalking and retaliation involving any member of the TCU community, except as otherwise provided within the <a href="Policy on Prohibited Discrimination">Policy on Prohibited Discrimination</a>, Harassment and Related Conduct.

Mandatory Reporters may receive this information in a number of ways. For example, a complainant may report the information directly to a Mandatory Reporter, a witness or third-party may provide information to a Mandatory Reporter, or a Mandatory Reporter may personally witness such conduct. A Mandatory Reporter's obligation to report such information to the Coordinator does not depend on how he/she received the information. Mandatory Reporters must provide all known information about conduct that raises Title IX or VAWA issues to the Coordinator, including the identities of the parties, the date, time and location, and any other details. Failure of a Mandatory Reporters to provide such information to the Coordinator in a timely manner may subject the employee to appropriate discipline, including removal from a position or termination of employment.

Mandatory Reporters cannot promise to refrain from forwarding the information to the Coordinator if it raises Title IX or VAWA issues or withhold information about such conduct from the Coordinator. Mandatory Reporters may provide support and assistance to a complainant, witness, or respondent, but they should not conduct any investigation or notify the respondent unless requested to do so by the Coordinator.

Mandatory Reporters are not required to report information disclosed (1) at public awareness events (e.g., "Take Back the Night," candlelight vigils, protests, "survivor speak-outs," or other public forums in which students may disclose such information (collectively, public awareness events); or (2) during an individual's participation as a subject in an Institutional Review Board approved human subjects research protocol (IRB Research). TCU may provide information about Title IX rights and available resources and support at public awareness events,

however, and Institutional Review Boards may, in appropriate cases, require researchers to provide such information to all subjects of IRB Research.
